**Judge Responsibilities****As a judge in the Saskatchewan BBQ Championships, you must:**

- Arrive at the judge's meeting on time – 10:00 AM on the day of judging. Judges not in their chairs at 10:00 sharp will not be eligible to participate.
- Be available at the venue from 10:00 am to 2:30 PM on that day for judging.
- Refrain from talking to other judges at your table during judging
- Taste and objectively judge everything that is presented to you
- Refrain from consuming alcohol before or during the judging process
- Be 16 years of age or older
- Refrain from visiting with BBQ teams on the morning of judging
- **Come with a big appetite and be ready to have a good time!**

Judging positions may be filled by anyone willing to meet the above requirements, but preference will be given to those with prior experience or a genuine interest in Southern-style barbecue. The number of judging positions required is determined by the number of teams to enter the contest; We expect to require 12 or 18 judges.
